\$25 MAIL-IN REBATE

Get a \$25 rebate check back from Act On Energy on your purchase of an eligible ENERGY STAR® qualified dehumidifier for your home. This rebate is good for purchases made June 1, 2010 through May 31, 2011 or until program funding is exhausted. Please allow six to eight weeks for processing.

TO RECEIVE YOUR REBATE, PLEASE FOLLOW THESE STEPS CAREFULLY:

1. Fill out this form completely and mail it to the address below.
2. Include a copy of your dated sales receipt and/or invoice showing the manufacturer, model number, and price of the ENERGY STAR qualified dehumidifier that you purchased.
3. Include a copy of your most recent Ameren Illinois **residential** electric bill.
4. All rebate requests must be postmarked no later than July 1, 2011.
5. Incomplete information will delay or disqualify your rebate.
